	law to cover college tuition for children of EMS workers in the event of a LODD.	
Medicaid Project	Jim Duke gave a detailed report on the status of our initiative

	which EMS gets reimbursed in order to increase Medicaid	
	rates.	
	History: There have been many healthcare organizations in	
	many states that have successfully implemented this kind of	
	program. It has worked well for them for many years.	
	There are two options:	
	Provider Assessment- only option available for	
	private services and requires a statutory change.	
	2. IGT- second option available to government services	
	and requires a regulatory change.	
	KAPA members need to decide and ultimately need to agree	
	and unite to support one method to support in the	
	legislature.	
	EMS in Kentucky has been underpaid and we have tried for	
	more than 25 years to find a way to get a significant increase	
	from Medicaid. This is probably our best and last way to	
	make a positive impact. This system would increase	
	reimbursements to EMS by roughly 17 million dollars.	
	Services with the highest number of Medicaid patients would	
	benefit the most.	
	KAPA plans to hold a special meeting in August to explain	
	and discuss this with the providers. We also want to	
	approach the Kentucky Judges Association and Kentucky	
	League of Cities to ask for a meeting to discuss this with
